Important Instruction for Pakistan Nationals

- 1. Pakistan National should register at FRO within 24 hours after arrival in India. If not, He / she should pay late registration fees of 30 US \$.
- 2. Pakistan National should submit all documents required for registration along with registration form which are mentioned at www.punepolice.gov.in
- 3. For registration of Pakistan National his/her house owner should submit 'c' form.
- 4. For first visa extension they should approach directly to Government of Maharashtra, Home Department, Mumbai.
- **5**. Those who are on visit visa, not allowed to acquire any type of Property and not allowed to run Business.
- 6. Name of new born child to Pakistani Nationals should get New Passport from High Commission of Pakistan, New Delhi or should be endorsed on their Mother's Passport and inform to FRO office.
- 7. Pakistan National can use NORI visa facility for 90 days once in the year.
- **8.** Applicant personally should be present at the time of collection of R.P.
- **9.** At the time of collection of RP bring the original Passport and Original RP issued by Check Post of entry.
- 10. Applicant should submit application for extension (LTV) before 30 days of R.P. validity.

Important Instruction for Bangladesh Nationals

- 1. Bangladesh National should register at FRO within 07 days after arrival in India. If not, He / she should pay late registration fees of 30 US \$.
- 2. Bangladesh National should submit all documents required for registration along with registration form which are mentioned at www.punepolice.gov.in
- 3. For registration of Bangladesh National his/her house owner should submit 'c' form.
- 4. Those who are applying for Long Term Visa extension (LTV) should approach directly to Government of Maharashtra, Home Department, Mumbai at the first time.
- 5. Name of new born child to Bangladesh Nationals should get New Passport from High Commission of Bangladesh, New Delhi or should be endorsed on their Mother's Passport and inform to FRO office.
- 6. Bangladesh National can use NORI visa facility for 90 days once in the year.
- 7. Applicant personally should be present at the time of collection of R.P.
- 8. At the time of collection of RP bring the original Passport.
- 9. Those who want to apply for PCC should approach to the Govt. of Maharashtra, Home Department, Mumbai. They should submit Xerox copy of the whole passport including arrival, Departure stamp and visa pages, Copies of all residential permits, Copies of all educational documents, Residential proof (leave and license agreement) along with application.
- 10. Applicant should submit application for extension (LTV) before 30 days of R.P. validity.
